## VALUE ADDED TAX (AMENDMENT) ACT, 2025

### AN ACT TO AMEND THE VALUE ADDED TAX ACT

[Date of Assent 31<sup>st</sup> March 2025]

Enacted by the Parliament of The Bahamas

#### 1. Short title and commencement.

- (1) This Act, which amends the Value Added Tax Act, 2014 (*Ch. 370A*), shall be cited as the Value Added Tax (Amendment) Act, 2025.
- (2) This Act shall come into operation on the 1<sup>st</sup> day of April, 2025.

#### 2. Amendment of section 2 of the principal Act.

Section 2 of the principal Act is amended in subsection (1), by the insertion, in the appropriate alphabetical order, of the following new terms and accompanying definitions —

““**food store**” means a business -

- (i) where at least 10% of its 2024 turnover under its business licence was from the sale of unprepared food for human consumption;
- (ii) licensed to operate as a pharmacy;

“**reduced-rated importation**” means a taxable importation of goods of a description specified in the *Fourth Schedule* chargeable for VAT at a five percent rate;

“**reduced-rated supply**” means a taxable supply of goods of a description specified in the *Fourth Schedule* chargeable for VAT at a five percent rate;

“**unprepared**” means a supply of goods that remains in its original purchased state and has not been altered by-

- (a) cooking, heating, or food preparation by the supplier; or

- (b) assembling the good or goods into ready-to-eat meals by the supplier,
- but includes-
- (i) packaging or assembly into different quantities by the supplier; or
  - (ii) packaging or assembly with other items by the supplier;”.

### **3. Amendment of section 6 of the principal Act.**

Section 6 of the principal Act is amended by the deletion of subsection (1) and the substitution of the following —

- “(1) Value added tax imposed under section 4 on a taxable supply and a taxable importation is chargeable at —
- (a) a zero percent rate on the value of such taxable supplies and taxable importations for the time being specified in the *First Schedule* subject to such conditions and restrictions as may be prescribed in regulations and VAT Rules;
  - (b) a reduced rate of five percent on the value of such taxable supplies and taxable importations for the time being specified in the *Fourth Schedule* if sold unprepared in a food store and subject to such conditions and restrictions as may be prescribed in regulations and VAT Rules; and
  - (c) a standard rate of ten per cent on the value of any taxable supply and taxable importation that is not zero rated or reduced rated.”.

### **4. Amendment of section 13 of the principal Act.**

Section 13 of the principal Act is amended in subsection (2) by the deletion of subparagraphs (d)(ii) and (iii) and the substitution of the following —

- “(ii) a taxable supply is a standard rated, zero-rated, reduced-rated, or an exempt supply;
- (iii) a taxable importation is a standard rated, zero-rated, reduced-rated, or an exempt importation;”.

### **5. Amendment of section 52 of the principal Act.**

Section 52 of the principal Act is amended—

- (a) in subsection (1) by the deletion of paragraph (c) and the substitution of the following—

“(c) the VAT applicable to the supply changes because—

  - (i) the nature of the supply is fundamentally varied or altered;

- (ii) the nature of the supply changes from an exempt supply to a taxable supply or vice versa; or
  - (iii) the rate of tax applicable to the taxable supply has changed;”; and
- (b) by the deletion of subsection (6) and the substitution of the following—
  - “(6) Subject to subsection (8), where output tax actually accounted for by a registrant supplier exceeds the output tax properly chargeable in relation to the supply, the registrant supplier may claim an input tax deduction for the amount of the excess in the tax period in which the later of the event or events referred to in subsection (1) or the taxable supply occurred.”.

**6. Amendment of section 71 of the principal Act.**

Section 71 of the principal Act is amended in subsection (1) by the deletion of paragraph (a) and the substitution of the following —

- “(a) a taxable person, due to fraud, negligence, or misrepresentation by the recipient of the taxable supply, has incorrectly treated the supply as a reduced-rated, exempt, or zero-rated supply;”.

**7. Amendment of section 96A of the principal Act.**

Section 96A of the principal Act is amended—

- (a) by the deletion of the head-note and the substitution of the following—
  - “Minister may make an order to amend reduced-rated, zero-rated, and exempt schedules, and to defer VAT.”; and
- (b) by the deletion of subsection (1) and the substitution of the following —
  - “(1) The Minister may by order published in the Gazette amend the existing Schedules or defer payment of tax on the supply within The Bahamas of any goods or service.”.

**8. Insertion of Fourth Schedule into the principal Act.**

The principal Act is amended by the insertion, immediately after the Third Schedule of the following—

**“FOURTH SCHEDULE**

(sections 2 and 6)

## REDUCED-RATED SUPPLY OF GOODS AND IMPORTATIONS
